PartB. CV SUMMARY (max. 3500 characters, including spaces)

In my research career I have always sought to analyze the history of America from an Atlantic perspective. The spaces linked to the Atlantic constitute one of the historiographic and cultural categories that are articulated with a geography not delimited by institutional limits such as the Estate, with its changing borders and its imperfect conjunctions between political loyalties and geographical limits. The main objective has been the analysis of the phenomena that the exchange produced in the Atlantic World, especially in the Caribbean,

since the Caribbean is the laboratory of the Atlantic World where cultural and population transfers can be analyzed, and the reception and adaptation of models and theories coming from other continents. I have analyzed the historical processes based on conjunctures and structures of exchange and dialogue in a specific space, which originated new societies and mestizo cultures with shared characteristics. From the studies on population policies and movements within the different regions in the Antilles, I turned to work on the various ways to devise society and the nation, by taking certain populations established following processes of exclusion/inclusion, based on ethnic or "racial" categories. An important area of this research has been centered on *the constitution of "race" as an explanatory cultural category of social, cultural and political phenomena*, by using studies and fundamentals from Anthropology, History of Science and History of Concepts.

- Networking with colleagues from different institutions and disciplines has offered me the opportunity to approach studies from different angles and points of view, and -in this way, obtain a broader, dynamic and transversal vision of History,
- I have carried out studies within the framework of 27 projects financed by official institutions--in 1990 and 2021: 19 projects as IP(Principal Investigator) and being a member of 10 national or international projects. The results of these studies have appeared in monographs/collective books, many of which I have coordinated and international scientific journals of high impact.
